

BUMPER CARS WITH ARENA

REQUIREMENTS:

- 1-2 Attendants (Line maintenance and Volunteer) CC&E provides one for loading.
- Attendant allows players to enter the play area and be escorted to their cars.
- 40L x 40W x 10H space needed for Arena
- 1 Dedicated 20 amp circuit within 100' CC&E will provide heavy gauge extension cords.
- Flat and level pavement only. Area needs to be swept and clean with no cracks.
- 4-8 Participants. 2 children per car, 1 adult, or 1 adult with 1 child.
- Minimum Height: 54" to ride alone.
- Max 1 child and 1 adult per car and maximum 325 lbs per car.
- Recommended Participant Ages: 5 and up
- Please note: No credits will be issued if a car goes inoperable.
- The temperature must be above 45 degrees.

PLEASE...

- The car play area should be level and free of debris. Cars should only be run on level ground. The cars are not equipped with a braking mechanism.
- ABSOLUTELY No Sharp Objects allowed near the Kaboom Area. Remove: All loose items are not to be taken into the bumper car. Place items in safe location or with parents.
- Do not enter the arena unless Operator is present.
- Operator can terminate play for not following rules.
- Rider is to insert one arm, shoulder and neck through safety belt loop, then fasten to the clip.
- Before the play car stops completely, no players therein would be allowed to get on and off.
- Participants should not engage in a Game if they have any of the following conditions: Current or previous injury to the back or neck; Chronic knee or other joint conditions; Any respiratory conditions, including but not limited to asthma or bronchitis; Any heart related or circulatory conditions or Pregnancy.

OPERATOR AWARENESS:

- Wind conditions must be less than 20 mph; if wind gusts begin, stop ride operations immediately.
- Adult Operators are required for safe use of Inflatable Games.
- Line Operator should point out and make participants aware of the posted warning labels and safety rules.
- Line Operator should remove all debris from the area prior to allowing participants inside the arena.
- Line Operator should keep all spectators outside the Game and maintain at least a 3 foot perimeter around it. Do not allow spectators to sit or lean on the arena.
- · Line Operator must not allow access to the rear of the arena or near the inflation blower and power supply.
- The CC&E operator will always limit participants to the number specified above.
- Silly string, foam or like products are not permitted in any event where Inflatable Games are being used.
- Duct tape may not be used to secure electrical cords or to post rules on games; consult CC&E for alternatives.

Bumper Cars Release of Liability and Assumption of Risk

- 1. Renter acknowledges that riding in a bumper car entails risks that could result in physical or emotional injury, paralysis, death, or injury or damage to me, to property, or to third parties. I understand that the risks cannot be eliminated without jeopardizing the essential qualities of the activity. The risks could result in musculoskeletal injuries, including head, neck, and back injuries.
- 2. Renter accepts and assumes all the risks of participation in this activity. Renter participants in this activity is purely voluntary, and I elect to participate in spite of the risks.
- 3. Renter releases and agrees to indemnify and hold harmless CC&E from any claims that are in any way connected with my participation in this activity or my use of bumper cars equipment, including claims that CC&E was negligent. However, I do not release any claims related to intentional or reckless acts by CC&E.
- 4. Renter agrees to bear the costs of any injury or damage.
- 5. Renter agrees that if I bring a lawsuit against CC&E, I will do so solely in Kansas and the substantive law of Kansas will apply in that lawsuit without regard to the conflict of law rules. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

By signing our contract, Renter acknowledges that if anyone is hurt or property is damaged during participation in this activity, Renter may be found by a court of law to have waived my right to maintain a lawsuit against CC&E on the basis of any claim from which Renter has released them.
