



**DELUXE MECHANICAL BULL**

#### **REQUIREMENTS:**

- 1 Attendant to assist with line control and verify waiver signatures. CC&E keeps the waivers on file for insurance purposes.
- Customer to provide a strong volunteer to assist the participants with getting on and off the bull.
- All riders must read the rules of play and fill out a waiver prior to riding the bull. A parent or guardian must sign the waiver for anyone under 18 years of age.
- 1 Dedicated 20 amp circuit with 25' for the bull console, and 1 dedicated 20 amp circuit within 100' for the inflated base of setup area.
- Size: 18L x 18W x 10H Indoor space required: 20' X 20' level area free of debris/sharp objects.
- Electrical outlet can NOT have a reset/test button (CFG1)
- If indoors, remove center bar in double door for entrance on ground level. The inflatable can't be carried up or down stairs or transported in an elevator.
- Maximum 1 participant at a time
- Minimum height: 48" tall. A smaller child can ride with an adult next to them.
- Maximum weight: 300 lbs. per rider.
- Ability to drive up and drop equipment is preferred. If not, we must be able to park no more than 50' from setup area. The equipment can't be transported more than 100 feet.
- If outdoors, the temperature must be above 45 degrees.

#### **OPERATOR AWARENESS:**

- ALL RIDERS MUST BE DESIGNATED IN SOME WAY (WRISTBAND, HAND STAMP, CHECKLIST...) AS HAVING SIGNED ALL FORMS AND WAIVERS FOR PERMISSION TO RIDE.
- This ride MUST NOT be operated without a trained adult operator. CC&E provides the operator for the bull for this requirement.
- This ride may NOT be operated when it is raining or snowing (risk of electrocution) or in winds of 20 mph or more.
- All riders must remove: shoes; all items from pockets; food, gum or retainers from mouth; eye glasses; hair clips, watches, earrings and necklaces; any sharp items on their person.
- Operator can terminate a rider's participation for not following rules.
- Participants should not engage in this activity if they have any of the following conditions: Epilepsy; Current or previous injury to the back or neck; Chronic knee or other joint conditions; Any respiratory conditions, including but not limited to asthma or bronchitis; Any heart related or circulatory conditions or Pregnancy. Do not allow anyone on this ride who is under the influence of alcohol or drugs.
- Verbally warn each rider that they will be thrown from the ride; If the rider has any doubt, they must not ride. Instruct each rider how to ride the bull in the correct riding position.
- Ensure each rider is wearing the Automatic Stop Sensor belt/lanyard, instruct the rider to connect the magnet to the connection plate located behind the head, the operator can now start the ride.
- Do not allow spectators to sit or lean on or around the inflatable bed of this ride.
- Once a rider has dismounted, the operator must instruct the rider to exit the inflatable cushion via the doorway. DO NOT ALLOW another rider entry to the inflatable before the existing rider has vacated the ride.

#### **IN THE EVENT OF AN EMERGENCY:**

- In the event of an emergency, depress the EMERGENCY STOP BUTTON and remove the key. Instruct the rider to evacuate the ride safely offering assistance if it is safe to do so. Once the rider has evacuated the ride, turn off the main power to the control console and blower. In the event of loss of power to the inflatable causing the it to deflate, depress the EMERGENCY STOP BUTTON and remove the key. Instruct the rider to evacuate the ride safely offering assistance if it is safe to do so. Once the rider has evacuated, turn off the main power to the control console and blower.
- The EMERGENCY STOP BUTTON must always be depressed and the key removed during setup or when the CONTROL CONSOLE is unattended.

#### **Mechanical Bull Ride – Required Paperwork Procedures**

The following procedures are **required** to be completed by your organization in order for Creative Carnivals & Events to allow your participants to ride the **Mechanical Bull Ride**.

1. Please read all Mechanical Bull safety requirements, operator instructions and emergency instructions provided by Creative Carnivals before your event.
2. The **MECHANICAL BULL RELEASE OF LIABILITY AND ASSUMPTION OF RISK** and the **MECHANICAL BULL DISCLAIMER NOTICE**, provided within the Equipment Rules document you receive with your contract from Creative Carnivals, should be provided to all potential participants (or their parents if under the age of 18).
3. No person shall be allowed to ride our Mechanical Bull without the proper signatures on the above form. It is the responsibility of your organization to collect signed forms and to provide a way of distinguishing those persons who have been cleared to ride so that our Mechanical Bull operator can easily identify them at your event. The preferred distinguishing manner for these cleared riders would be a particular color wristband that has been placed on arms by your organization prior to riders approaching the ride. Creative Carnivals & Events will provide these wristbands.
4. Our Mechanical Bull operator **Will Not** allow anyone to ride who cannot be identified as having provided signed participant forms. **Our Operator's decision is final. If any individual fraudulently obtains a wristband without completing the required forms, Creative Carnivals & Events will not be held responsible for any injury resulting from the ride.**
5. Your organization should make copies of **All** signed participant forms for its records and provide the signed originals to Creative Carnivals & Events.

## Mechanical Bull Release of Liability and Assumption of Risk

In consideration of the services of Creative Carnivals & Events, LLC, its employees and agents (collectively CC&E), I agree to release, hold harmless and indemnify CC&E, on behalf of myself and my family members, Partners, heirs and assigns as follows:

1. I acknowledge that riding a mechanical bull entails risks that could result in physical or emotional injury, paralysis, death, or injury or damage to me, to property, or to third parties. I understand that the risks cannot be eliminated without jeopardizing the essential qualities of the activity. The risks could result in musculoskeletal injuries, including head, neck, and back injuries.
2. I accept and assume all the risks of participation in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I release and agree to indemnify and hold harmless CC&E from any claims that are in any way connected with my participation in this activity or my use of Mechanical Bull & Inflatable Ride equipment or facilities, including claims that CC&E was negligent. However, I do not release any claims related to intentional or reckless acts by CC&E.
4. I have adequate insurance to cover any injury or damage I may cause or suffer while participating or I agree to bear the costs of any injury or damage.
5. I agree that, If I bring a lawsuit against CC&E, I will do so solely in Kansas and the substantive law of Kansas will apply in that lawsuit without regard to the conflict of law rules. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

### MECHANICAL BULL DISCLAIMER NOTICE:

PLEASE BE ADVISED:

**ALL PARTICIPANTS MUST ABIDE BY THE FOLLOWING RULES & SIGN THE DISCLAIMER NOTICE.**

**YOU WILL BE THROWN FROM THIS RIDE.**

YOU MUST NOT RIDE THE MECHANICAL BULL IF YOU SUFFER FROM THE FOLLOWING:

- BACK, NECK OR SHOULDER PROBLEMS
- PREGNANCY
- EPILEPSY
- MOTION SICKNESS
- UNDER THE INFLUENCE OF DRUGS OR ALCOHOL
- ANY AILMENT THAT CAN BE AGGRAVATED BY THE MOTION OF THE RIDE

1. DO NOT USE THE HORNS AS GRAB HANDLES.
2. THE RIDER MUST SIT OVER THE CENTER OF THE UNIT.
3. DO NOT RIDE AROUND THE BULLS NECK.
4. DO NOT SIT ON OR AROUND THE INFLATABLE.
5. ONLY ONE RIDER AT A TIME.
6. PLEASE REMOVE FOOTWEAR AND ANY SHARP ITEMS OF JEWELRY, HAIR CLIPS, EYEWEAR ETC.

**THE OPERATORS DECISION IS ALWAYS FINAL.**

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against CC&E on the basis of any claim from which I have released them. I have had sufficient opportunity to read this agreement. I have read and understood it, and agree to be bound by its terms.
